Any Other Business

10.01 Councillor Mary Davies raised concerns regarding the picture of the coast at the square in Synod Inn. Councillor Bryan Davies explained that he had reported this to the County Council but aren't able to enforce this issue due to it being on private land.

10.02 Councillor Pit Dafis raised concerns about the gutters in Bwlchfadfa that they were full of leave, soil etc and that heavy machinery use of the road can affect the drainage.

10.03 Councillor Alun Evans raised his concerns about the new pay machines used at the County Council's car parks, he explained that the screen wasn't clear to use and was unhappy that the new machines don't accept cash. He asked Councillors Bryan Davies and Gareth Lloyd whether they knew the cost of such machines. It was explained that due to Covid 19 and Health and Safety that the County Council were reducing the use of cash.
